### **Executive Summary with Rationale and Impact:**

The proposed amendment would update the Denver Revised Municipal Code (DRMC 59-2) to allow properties that retain a zoning designation under Former Chapter 59 to access flexibility provided for accessory dwelling units (ADUs) in the concurrent Denver Zoning Code amendment for ADUs in Denver, including increased floor area maximums for ADUs and removal of maximum occupancy and exterior building material standards. We request an effective date of June 12, 2023 for this amendment. We also request that this DRMC amendment follow the proposed text amendment for accessory dwelling units that will be submitted at the same time as this request (i.e., this amendment would receive a bill number later than the ADUs in Denver DZC text amendment).
