Renovation of the interior of the existing 12-story Wellington E. Webb Municipal Office Building at 201 W. Colfax Ave. to upgrade dated and worn-out finishes, meet current building codes, and meet necessary ADA requirements. The interior renovation scope includes, but is not limited to, staff open and private offices, conference rooms, break areas, secure storage areas, public interface spaces, and other support functions. The project will require a phased and partial renovation including partial demo, new interior construction, updated finishes, data and technology upgrades, limited mechanical upgrades, limited electrical and plumbing ("MEP") systems, and security.
