Amends an intergovernmental agreement with Urban Drainage and Flood Control District (UDFCD), doing business as Mile High Flood District (MHFD), by adding \$4,000,000 (\$2,000,000 from MHFD and \$2,000,000 from the city), for a new total of \$22,400,000 for continued design and construction of drainage and flood control improvements for Weir Gulch from the South Platte River to 8th Avenue, located in Council District 3. This amendment will commit an additional \$2,000,000 in Mile High Flood District (UDFCD) funds, and \$2,000,000 in Wastewater Enterprise funds for the Weir Gulch Reach W1 Improvement Project to design and construct Drainage and Flood Control Improvements for a total agreement amount of \$22,400,000. The improvements will include acquisition, drainage, habitat, water quality, and recreation improvements in Weir Gulch from the South Platte River to 8th Avenue. This project is being managed through design and construction by UDFCD. UDFCD will not invoice DOTI for the additional contribution as we have used the 2023 funds for ongoing acquisition efforts.
