Type and Scope of services to be performed:

To support and engage TANF eligible participants to develop strategies that address individual and family needs, DHS will work jointly with Thriving Families to provide the following: Intensity, frequency, and duration of services. Overall, the Thriving Families, MotherWise program engages women for approximately three (3) months, prior to or soon after the birth of a baby. Mothers participate in a core workshop with twenty-four (24) hours of content and approximately six hours of one-on-one case management services (i.e., family support) during their engagement with the program. In addition to these core services, Thriving Families also offers other services, including workshops on parenting and infant care, postpartum depression prevention, and for couples (as appropriate), as well as trauma-informed therapy.
