**Executive Shine, Inc.**

**Type and Scope of services to be performed:**

Executive Shine, Inc. will design, build, manage, and lease Executive Shine on Concourses A, B and C in the Concourse A East & West Center Core, Concourse B East & West Center Core, and Concourse C East Center Core. Executive Shine, Inc. has committed to design and build these spaces To amortize Executive Shine, Inc.'s capital investment, they will receive a contract term of 5 years. Denver International Airport (DEN) will receive the greater of either a guaranteed rent/Minimum Annual Guarantee (MAG) of \$24,000.00 or a percentage rent of gross sales at 12%. MAG is the initial calculation based on the projected gross sales by the concessionaires for the space multiplied by the proposed percentage fee listed above. MAG is recalculated each contract year and will be equal to the greater of the initial MAG or eighty-five (85%) of the total Privilege fees payable in the prior Contract Year.
