Amends a contract with Maple Star Colorado, doing business as Clarvida, by adding \$175,000 for a new total of \$1,054,000 and 8 months for a new ending date of 2-28-2025 to ensure home studies are performed by state-trained and certified social workers, and to continue providing face-to-face contact visits for children in out of home care to ensure children’s wellbeing and safety are met, citywide.
