**A resolution approving a proposed Amendatory Agreement between the City and County of Denver and FCI Constructors, Inc. to add compensation and two years for a new end date for on-call construction services as needed citywide.**

Amends a contract with FCI Constructors, Inc. by adding \$10 million for a new total of \$25 million and two years for a new end date of 6-26-24 for on-call construction services as needed, including deferred maintenance and renovation work, in municipal buildings, citywide (DOTI-202160288-01; 201947351-01).
