#### **A bill for an ordinance approving a proposed Intergovernmental Agreement between the City and County of Denver and Regional Transportation District, for mutually beneficial infrastructure projects for the National Western Center and the North Metro Rail Line.**

Approves an intergovernmental agreement with the Regional Transportation District (RTD) for \$3,528,706.84 for mutually beneficial infrastructure projects for the National Western Center and the North Metro Rail Line in Council District 9 (DOTI-202057174). The last regularly scheduled Council meeting within the 30-day review period is on 11-8-21. The Committee approved filing this item at its meeting on 10-5-21.

The City and RTD agreed in the 2013 North Metro IGA to certain funding obligations to enable

the construction within the Denver boundaries and to cooperate with regard to certain infrastructure improvements related to the development of the North Metro Rail Line. The 2013 agreement considered the need for future intergovernmental agreements to address specific issues.

This IGA provides funding for coordination between RTD and the City related to multi-modal transportation connections, including the 48th / Brighton Station, Station Plaza & Pedestrian Bridge, and Marion Underpass at the National Western Center.
