Approves a contract with Kraemer North America, LLC for 2024 On-Call Construction Services - Bridge & Structural Project Delivery (LARGE) contract (DOTI-202472377-00) for a term of 3 years from 4/1/2024 to 3/31/2027 and a contract capacity of \$30,000,000.00.

The City and County of Denver, Department of Transportation and Infrastructure ("DOTI") Bridge Group is seeking general contractors to provide On-Call construction services as needed for construction work on bridges, culverts, and/or miscellaneous structures that facilitate vehicular and pedestrian traffic as well as electrical elements that facilitate lighting in these areas. The City anticipates awarding multiple contracts to multiple general contractors.
